The legal voters of the Towns of Burke, Concord, Lunenburg, Lyndon, Newark, Sheffield, Sutton and Wheelock, being of Kingdom East Unified Union School District, are hereby notified and warned to meet at the official polling places in their respective Towns, on Wednesday, June 19, 2019 at the following locations during the listed times:

To vote by Australian ballot upon the following Article of business:

Article 1: Shall Kingdom East Unified Union School District issue general obligation bonds or notes in an amount not to exceed Twenty-Four Million Dollars (\$24,000,000.00), subject to reduction from available state and federal grants-in-aid, appropriations and reserves, for the purpose of financing the cost of the Burke School Expansion Project, repair and replacement of the Concord Graded School Gymnasium and renovations and expansions of the Concord Graded School, and renovations and expansions at the Lunenburg School, the estimated cost of such improvements being Twenty-Four Million Dollars (\$24,000,000.00)?

State funds may not be available at the time this project is otherwise eligible to receive state school construction aid. The District is responsible for all costs incurred in connection with any borrowing done in anticipation of the receipt of school construction aid.


Upon closing of the polls, the ballot boxes will be sealed, re-opened at the polling place in the Town of Lyndon, the ballots commingled and publicly counted by representatives of the Boards of Civil Authority of the Towns of Burke, Concord, Lunenburg, Lyndon, Newark, Sheffield, Sutton and Wheelock under the supervision of the Clerk of the Kingdom East Unified Union School District.

The legal voters of the Kingdom East Unified Union School District are further warned and notified that an informational meeting will be held for the purpose of explaining the subject proposed school building improvements and the financing thereof on Tuesday, June 11, 2019, at 6:00 p.m. at the Lyndon Town School in Lyndonville, Vermont.

The legal voters of the Kingdom East Unified Union School District are further notified that voter qualification, registration and absentee voting relative to said special meeting shall be as provided in Sections 706u-706w of Title 16, and Chapters 43, 51 and 55 of Title 17, Vermont Statutes Annotated.
