- **Dianna Simpson** was elected **Treasurer**
 - **1022-yes votes Overvotes-0 Undervotes-220 Write-in-12**
- **Assistant Treasurer**
 - There were not a sufficient number of write in votes for one person (min of 60)to qualify a position
 - **Overvotes-0 Undervotes-1177 Write-in-77**


Passed 784-yes votes 387-no votes Overvotes-1 Undervotes-82


